SUPPLEMENTARY RESULT NOTICE FOR THE POST OF FOREST GUARD

1. Department of Forests and Wildlife, Govt. of NCT of Delhi vide its Direct Recruitment Notice dated 27/12/2019 with closing date 16.02.2020 had advertised 211 vacancies for the post of FOREST GUARD in the Department of Forests and Wildlife, Govt. of NCT of Delhi.
2. Department of Forests and Wildlife conducted Computer Based Test through EdCIL (India) Limited for recruitment for the post of Forest Guard from 1-7 March, 2021.
3. Department of Forests and Wildlife called 471 candidates for Physical Standard Test, Walking Test, Document Verification and Biometric verification for the post of Forest Guards.
4. On the basis of Written Examination, Physical Standard Test/ Walking Test, Document Verification, Biometric Verification and Medical examination, final result notice for the post of Forest Guard was declared by the department on 28.09.2022.
5. As posts of Forest Guard of certain categories remain unoccupied due to resignation, non acceptance of offer of appointment and rejection in medical examination, Department of Forest & Wildlife called 63 candidates (45 candidates on 23.12.2022 & 18 candidates on 23.01.2023) as per merit list for Physical Standard Test, Walking Test, Document Verification and Biometric verification for the post of Forest Guards.
6. On the basis of Written Examination, Physical Standard Test/ Walking Test, Document Verification and Biometric Verification, the following candidates are provisionally recommended as per their merit in Computer Based Test placed at **Annexure-1**.
7. The updated category wise Normalized marks scored by the last candidate provisionally recommended are as under:-

8. Based on the qualification in Physical Standard Test, Walking Test, Document Verification and Biometric verification candidates are required to undergo Medical Examination. The Final Selection of the candidates is subject to clearing of Medical Examination.
9. The selection of all 08 candidates (**Annexure-1**) shall be further subjected to thorough verification of the candidature of the candidate by the Department including the identity of the candidate.
10. While every care has been taken in preparing the result, the Department of Forests and Wildlife reserves the right to rectify errors and omissions, if any, detected at any stage.
11. This issues with the prior approval of the Competent Authority.
