
Terms & Conditions

1. Permission to Prune the trees is granted at his/her own risk and without prejudice to the claim(s) of any other person/s who may be having any right(s) over the land or the trees.
2. The applicant shall ensure by expert supervision that the pruning is done scientifically, and only to the necessary and permitted extent, without causing any permanent damage to the health or shape of the tree. In case of any unnecessary of permanent damage to the tree, the applicant will be liable for prosecution under the provisions of Delhi Preservation of Trees Act, 1994.
3. The applicant shall send the lops and tops arising out of pruning to the nearest public crematorium managed by MCD/NDMC at his expense, and submit copy of the receipt from such crematorium to this office.
4. Pruning of trees and transportation of forest produce arising wherefrom to the public crematorium shall be completed within 30 days.
