TERMS & CONDITIONS OF THE NIQ

1	Submission of /quotation shall amount to bidder’s acceptance of the terms and conditions of the tender by the bidder.
2	Mode of payment would be subject to satisfactory completion of work and its verification.
3	Bidder shall quote the rates against this tender on a ‘single responsibility’ basis so that the Tender price covers contractor’s all obligations and liabilities. The rates and prices quoted by the Bidder shall be inclusive of all Taxes. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations.
4	The bidder should be from NCR and should be registered with /Trade & Taxes department, GNCTD, and should quote their GST Regn no. allotted by Deptt. of Trade & Taxes, GNCTD, and PAN no. allotted by the Income Tax Deptt.

5	The Dy. Conservator of Forests (West) reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason therefore.
6	The rates quoted by the tenderer shall remain valid for the period of 06 months from the date of quotation opening date mentioned above, for the subject work and the Department shall not be responsible for payment of any extra on account of escalation of costs during the said period.
7	The department shall not be responsible for payment of any compensation on account of any loss caused to the bidder/tenderer due to natural calamities or other supervening impossibilities.
8	The tenderer shall abide by the provisions made under the Labour Laws/GST and other relevant Statutes as applicable in execution of the work and shall be responsible for making good/ payment of compensation, if any, to any workman or material during execution of the contract.
9	In case of any dispute arising out of the execution of the terms & condition of this short term tender or part thereof, the decision of the Conservator of Forests, GNCT of Delhi shall be final and binding on both the parties. In the event of the disputes still remaining unresolved, the appeal shall rest with the PCCF/HOD, Deptt. 10	All disputes arising out of the execution of the agreement shall be subject to the jurisdiction of the Courts at Delhi.
11	The performance of the work is subject to social auditing and periodic monitoring by internal/ external agencies.


